ACT plus Writing	Grade 11 in Reading, English, Writing, Math & Science	ACT with Writing helps students understand what they need to learn next to build rigorous high school course plans and identify career areas that align with their interests. It can be used for college enrollment, scholarships, and NCAA eligibility requirements.	Wisconsin State Statute 118.30	ACT with Writing takes 3 hours, 55 minutes to complete, including breaks.	The ACT is administered annually in the spring.	Student Score Reports are available online and mailed 5-8 weeks after the assessment.
ACCESS for All	Grades K-12, English language proficiency for students identified as English learners (ELs)	ACCESS allows educators, ELs, and families to monitor EL's progress in acquiring academic English in the domains of speaking, listening, reading, and writing.	Every Student Succeeds Act (ESSA) and Wisconsin State Statute 118.30	The ACCESS test is untimed, and students have the time needed to produce scorable content. ACCESS typically takes 1-4.5 hours to complete, depending on grade and test format.	ACCESS is administered annually in the winter.	Individual Score Reports are available electronically in the spring or summer and paper copies are mailed early the next school year.
Assessment of Reading Readiness	Grades 4K-3 for reading readiness	Districts must assess fundamental reading skills in order to inform and identify students with reading needs; data is used to provide intervention.
